# **CNHRPC Transportation Improvement Program (TIP)**

CNHRPC began the biennial update of the Regional Transportation Improvement Program (TIP) to cover Fiscal Years 2019-2028 on December 16, 2016. The Transportation Improvement Program (TIP) is the central program management tool for structuring transportation improvements in the region. The FY 2017-2026 Transportation Improvement Program (TIP) consists of a list of transportation projects for the Central New Hampshire Regional Planning Commission (CNHRPC) region that are consistent with the goals and vision established in the comprehensive Regional Transportation Plan, a dopted in April, 2015.

In New Hampshire, each of the nine regional planning commissions prepares a Regional TIP every two years based on input from local municipalities, NHDOT and each planning commission's Transportation Advisory Committee (TAC). This is concurrent with the New Hampshire Department of Transportation's (NHDOT) Ten Year Plan update. The Regional TIP serves as a significant opportunity to fully understand the current transportation needs in the region. Just as the Ten Year Plan is established as the transportation project guide for New Hampshire, CNHRPC will utilize this regional TIP to plan for current and future transportation needs in the Central NH Region.

# Town of Dunbarton Visioning Session

On January 25th, the Town of Dunbarton, with assistance from CNHRPC staff, held a public outreach event in connection with the update to the Master Plan. Called the Visioning Session, it was held at the Dunbarton Elementary School. Approximately 40 residents were in attendance and provided input for each of the main Chapters in the Plan, including topics on existing and future land use, economic development, natural features, community facilities, transportation, and housing. The public input will be used, along with the results of a community survey, to inform the

## **CNHRPC Brownfields Assessment Program**

CNHRPC continues to work with our Qualified Environmental Professionals to finalize Phase I assessment reports and lay the foundation for Phase II assessments this spring and summer. The Phase II work will consist of soil testing and other data collection. Additionally, given the success of the program, more funding will be needed and CNHRPC has submitted a new grant application to EPA. This new grant requests the maximum amount possible: \$200,000 for hazardous substances and \$100,000 for petroleum. We look forward to hearing back from EPA in the spring or summer - just when our Phase II work will begin!


