Advisory and Staff Introductions

Brownfields Advisory Committee Members (BAC) around the table introduced themselves.

Review Meeting Notes: June 22, 2017

Meeting notes from the previous BAC looked correct and appropriate. Kate Emma Schlosser indicated that in the future, SSQAPPs should be sent directly to her and she would then distribute

Status of Current Sites

Current sites were discussed. Points included:

- Allied Tannery (Rip Patten discussed):
 - o Phase II work is complete.
 - o Gaps identified in the Phase II data and additional supplemental sampling will be done.
 - The SSQAPP for the supplemental sampling is currently in review.
 - A cleanup grant application was submitted to NH DES. [Kate Emma Schlosser indicated grant results could be ready by October]
 - Use analysis/market study for the site and the region to begin soon, looking at commercial uses as well as senior housing.
 - Redevelopment analysis will be done as well.
- Naughton Landfill (Rip Patten discussed):
 - Phase II assessment work is done.

- 2 tanks were removed.
- Soil under tanks assessed and no releases were identified
- A cleanup grant application was submitted to NHDES.
- A supplemental SSQAPP has submitted.
- A market study for the site/region to also be done looking at housing/senior housing/commercial/recreational uses.
- o An engineering analysis will be done to identify use restrictions and reuse options.

Woods Woolen Mill (Heidi Lemieux discussed):

- o Phase I done; limited phase II on the DRED parcel
- Soil sample found arsenic and PAHs at concentrations exceeding NHDES soil remediation standards.
- Fence was installed around the site this past spring.
- A draft Supplemental site investigation report was submitted to NHDES and USEPA this
- o A data gap analysis was proposed with some drilling and soil sampling.
- o NHDES cleanup grant has been submitted.
- A petroleum eligibility determination is to be submitted. [Mike Tardiff asked how soon before results come back on the determination; Heidi indicated a few weeks]

• Pittsfield Sites (Steve Rickerich discussed):

- The Pittsfield sites (16 Clark Street, AKA Freese site; and the Public Works Garage) came from the Plan NH Charrette area. These two sites are the first among several sites to be considered and could support a first phase in redevelopment.
- Phase I work has been done on both sites.
- SSQAPPs done on both sites.
- Phase II in the works currently
- Numerous monitoring wells were installed on the two sites.
- Evidence of buried solid waste, typically less than 10-15% by volume, was noted in test pits in the north portion of the Freese Property.
- Some moderate level PAHs and arsenic (background) were detected in Freese property soil samples near former tanks and in fill, though the laboratory results were ok for the most part.
- The Town Garage soils appeared/tested fairly clean.
- CNHRPC and Ransom me-t with the Board of Selectmen in July and they seem enthusiastic about the process.
- o Looking to set up a meeting with the Community Development Committee in town next.
- Next steps to be identified (additional candidate Sites, affirmation of preferred redevelopment plans).
