The CNHRPC, in coordination with the Southern NH Planning Commission (SNHPC), has completed a draft Comprehensive Economic Development Strategy (CEDS) for 20 CNHRPC communities and for 6 SNHPC communities. The CEDS is an advisory regional economic development strategy and is available for public review and comment until Monday October 8, 2018. ### Renewable Energy Rebate Programs Open

On August 29, the NH Public Utilities Commission (PUC) released the official approval for the Renewable Energy Fund (REF) rebate program budgets, including the:

- Residential Solar & Wind Rebate Program
- Residential Solar Thermal Rebate Program
- Residential Wood Pellet/Central Boiler/Furnace Rebate Program
- Low-Moderate Income Grants
- C&I Solar Rebate Program
- C&I Bulk Fuel Fed Wood Pellet Central Heating System Rebate Program
- C&I Competitive Grants

Total program budget is \$9,089,188. Applications that are currently waitlisted will

receive funding priority, and new applications will enter a public lottery to receive queue positions. Biomass rebate applications (residential & C&I) are due September 7th; lottery to be held September 12th at 1:00 PM at the PUC. Solar, solar thermal, and wind rebate applications (residential & C&I) are due September 17th; lottery to be held September 24th at 1:00 PM at the PUC.

### Local Source Water Protection Grants Available

The New Hampshire Department of Environmental Services (NHDES) is pleased to announce the availability of funds for Local Source Water Protection Grants. Specifically, grant money is available to develop and implement programs to protect existing (active or planned) sources of public drinking water. Since 1997, NHDES has made small grants to water suppliers, municipalities, and other local organizations for the purpose of protecting drinking water sources.
